I understand that I am spending the day as a volunteer for Ravenswood Community Services (RCS) and/or All Saints Episcopal Church (ASEC) and that there are risks and dangers inherent in my participating in this event or serving as a volunteer. I attest that I am physically capable of participating in this event or serving as a volunteer. I understand that my execution of this Waiver and Release is a prerequisite for my participation in this event or my serving as a volunteer for RCS and/or ASEC. I hereby assume any risk of loss, property damage, or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my participation in this event or my serving as a volunteer, whether cause by the negligence of the Released Parties (as hereinafter defined) or otherwise. I release, waive, discharge and covenant not to sue RCS and ASEC and their officers, directors, employees, agents, affiliates, as well as any event sponsors or other participating organizations and their respective officers, directors, employees, and agents (collectively, the "Released Parties") for any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to death, personal injury, or any other loss, injury, or damage of any kind whatsoever sustained to my person or property during my participation in this event or while serving as a volunteer, whether caused by the negligence of the Released Parties or otherwise. I agree to indemnify, defend and hold harmless the Released Parties from any loss, liability, damage or costs, including attorney's fees and court costs, that maybe incurred due to my participation in this event or my serving as a volunteer, whether cause by the negligence of the Released Parties or otherwise. I understand and agree that this waiver and release is binding on my heirs, assigns, and legal representatives. I grant full permission for organizers to use photographs and/or video of me and/or quotations from me and/or my name, without compensation, in accounts and promotions of this event and/or RCS and ASEC in perpetuity and in all forms of media now and forever known. I understand the need for confidentiality and will not discuss, photograph, or otherwise disclose identifying information about the neighbors seeking help from RCS/ASEC without prior permission from RCS, including any references to names, addresses, or other identifying information.
