RELEASE AND WAIVER OF LIABILITY

The parent and/or guardian of a minor child, on the child's behalf, and on behalf of ourselves, and our respective heirs, personal representatives, agents and assigns (hereinafter collectively referred to as "we", "our" and "us") do hereby RELEASE AND DISCHARGE, fully and forever, MANTZ IMAGINATION, LLC, d/b/a THE CHILDREN'S PLAY GALLERY, its past, current and future officers, directors, shareholders, agents, employees, predecessors, successors, insurer, and assigns (hereinafter collectively referred to as "The Children's Play Gallery") from any and all claims, actions, obligations and demands of any type (hereinafter collectively referred to as "claims"), whether now known or hereafter made known, arising due to any accident or occurrence at The Children's Play Gallery located at 126 E. We agree that any and all costs or damages resulting from property damage, theft, injuries or death due to our acceptance of these risks, including without limitation, medical and funeral bills, attorneys fees, damages for loss of use, pain and suffering and loss of consortium, shall be borne by us.
