



## VILLAGES OF KILN CREEK OWNERS ASSOCIATION 2020 POOL & FACILITY RULES

### HOURS OF OPERATION

OPEN: July 3- Sept 7, 2020    POOL TELEPHONE: 877-3309

#### REGULAR HOURS

Tuesday - Sunday            12:00 p.m.- 6:00 p.m.  
Closed Mondays

- The last 15 minutes of each hour (except closing hour) is a mandatory cleaning break. Pool PH and chemicals will be tested at this time as well. **The pool will be closed during this time period.**
- The pool will close early at 4pm on days when home swim meets are scheduled:  
July 6, 13, 23, 27
- Management reserves the right to close the pool in an emergency situation. In cases of lightning or thunder, the pool and deck areas will be cleared for thirty minutes following the first sighting of lightning and or sound of thunder. If thunder and lightning continues, the thirty minute period will start again until thunder and lightning has stopped and left the area.

### POOL RULES

The following rules and regulations are for the protection and benefit of all persons to ensure safe and sanitary operation of the swimming pool related facilities. The cooperation of the members will afford pleasant relaxation and recreation for everyone concerned. Members are requested to caution their children and their guests to observe the pool rules and regulations and to obey the instructions of the pool attendant and the lifeguards. Any failure to comply with the pool rules and regulations shall be considered sufficient cause for members to be deprived of the use of the swimming pool by the attendant, lifeguard on duty, or the Director of Operations appointed by the Association.

**SIGN-UP IS REQUIRED** prior to admission for 2020 pool season. Contact the HOA for sign-up information or go to [www.kilncreek.org](http://www.kilncreek.org). Click on “2020 Rec Pool Swim Sign Up”. We ask that you please sign up 24 hours in advance to process rec passes. If you do not show up within 20 mins of your allotted time, you forfeit your spot if other patrons are waiting.

All patrons are **REQUIRED** to sign indemnification/waiver paperwork prior to swimming.

1. Any person using the swimming pool shall dress in appropriate swimwear. No person shall be permitted to wear shorts, “cut-offs”, etc. in the swimming pool. Children who are not toilet trained must wear protective, tight-fitting plastic pants or swim diapers.

2. No person shall use the swimming pool unless the swimming pool is officially opened, and lifeguards are on duty. All persons shall obey the instructions of the lifeguards.

3. Patrons with colds, coughs, inflammation of the eyes, wearing bandages, having an infection or open sore or other unusual physical condition that may affect the health and welfare of other patrons, should refrain from using the pool. The lifeguards have the responsibility and authority to deny use of the pool to any patron affected with any recognizable unhealthy condition which may be transmitted by use of the swimming pool. All persons must take a cleansing shower before entering the swimming pool. Spouting of water from the mouth and similar unhygienic actions in the swimming pool or the swimming area is not permitted. **ALL PATRONS must adhere to current COVID-19 mandates/guidelines.**

4. The Association has defined the last 15 minutes as a **mandatory cleaning break**. The PH level and chemicals will be tested at this time. **The pool will be closed down at this time.**

5. **Swim Tests will be given** to all swimmers with a red or green rec. pass that would like to swim in the deep end (where diving board is) or in the lap lanes. All swimmers with a red or green rec. pass wishing to swim in water that is over their head (when feet are touching the bottom of the pool surface) will also be required to take and pass the swim test. The Swim Test consists of the following:

- A. Swim distance equal to the maximum width of the deep-water swimming area section of the facility without using a floatation device or anything else for support, such as touching the bottom, the wall or safety line.
- B. Jump into deep water, level off at the surface; tread water for one minute in a vertical position with the head and mouth above the water line (use of hands is allowed).
- C. Exit from the pool independently.

The lifeguards reserve the right at their discretion to request ANY swimmer (regardless of pass color) who appears to be overly tired or uncomfortable in deep water (even if they have passed the swim test already) to return to or remain in shallow water.

A bracelet will be given to each swimmer who has passed the Swim Test to show the pool staff that they have passed the test. A sticker will also be placed on the swimmers' Rec. Pass to show they have passed the Swim Test. If you wish to swim in any areas where the Swim Test is required, the bracelet shall be worn when swimming in those areas. If you have lost your bracelet, please inform an attendant.

7. Children under twelve (12) years of age must be accompanied by an identified responsible person, sixteen **(16) years** or older at all times within the pool area. The lifeguards are empowered to deny swimming pool privileges to any child who cannot demonstrate satisfactory swimming ability.

### **SAFETY CONSIDERATIONS**

- A. No running, pushing, dunking or rough play will be permitted in the swimming pool or the swimming pool area. Standing or sitting on another person's shoulders is not permitted.
- B. Persons unable to demonstrate their ability to swim properly to the lifeguards shall not be permitted beyond shoulder depth. Diving or jumping into the swimming pool from other than designated areas is prohibited.
- C. Glass containers, breakable objects, food and open drink containers are not permitted in the swimming areas. Food and open beverages may be consumed in the designated refreshment areas. Closed beverage containers (plastic) with tops and/or straws are permitted on the pool deck area only. Alcoholic beverages are not allowed.
- D. No intoxicants or intoxicated persons shall be allowed in the swimming pool or the swimming pool area.

- E. Portable playpens are permitted in designated areas as long as they do not obstruct use of the area by other patrons or obstruct the lifeguards view. Wheeled carriages are permitted, but shall be stored on the fence line, when not in use.
- F. No floats or rafts are permitted. Water wings & puddle jumpers are authorized in Kiln Creek Pools. Noodles are authorized, unless circumstances dictate otherwise, at the discretion of the lifeguard on duty. Beach balls, and Nerf type balls approved by the lifeguards, may be permitted in the pool area, as long as there is no potential safety hazard. **Water guns of all types are prohibited.** The lifeguards are empowered to deny use of balls at anytime where the safety and/or health of other swimmers may be affected.
- G. **Pool furniture will not be provided. Patrons are permitted to bring their own chairs, provided they are spaced 10-feet from other patrons/families. No umbrellas, tables, tents or other large items will be permitted. All such items shall be approved in advance by the pool staff.**
- H. Persons wearing glasses or goggles in the swimming pool must secure their glasses or goggles with an appropriate support band.
- I. Smoking is not permitted inside the fenced pool area.
- J. All refuse must be placed in containers provided for this purpose. Members are urged to assist in keeping the swimming pool and the swimming pool area clean.
- K. Members must provide towels for their own use and the use of their families and their guests.
- L. No pets are allowed in the pool area.
- M. Only authorized staff will be permitted in the manager's office or filtration room.
- N. Members and guest must stay clear of the lifeguards, in order not to distract them from their duties.
- O. All persons using the swimming pool and in the swimming pool area shall conduct themselves in a manner so as not to disrupt or impair the use and enjoyment of the swimming pool by others. Profanity or vulgar language is strictly prohibited. Violation of this rule may result in suspension of swimming pool privileges.
- P. Any injuries that occur on the premises must be reported immediately to the pool manager.
- Q. Gum chewing is prohibited in the pool area.
- Q. **Diving area is limited to three persons with ten feet of physical distance per diver.**
- R. **All persons not of the same household must always keep a 10-foot distance.**
- S. **We recommend that all persons entering the pool area wear a mask for protection.**

### **POOL ADMISSION**

**No one with a fever or symptoms of COVID-19 or known exposure to a COVID-19 case in prior 14 days, is permitted in the establishment. No exceptions.**

All persons using the swimming pool do so at their own risk. The Association assumes no responsibility for any accident or injury in connection with the use of the swimming pool or for any loss or damage to personal property in the swimming pool or the swimming pool area. All persons using the swimming pool agree not to hold the Association liable for any actions of any kind whatsoever, occurring within the Association property limits. All members are responsible for the actions of their children and their guests.

- All Residents must sign in and submit a valid Recreation Pass upon entering the pool area. Family members must sign in and pay the guest fee or submit a Seasonal Guest Pass **or get their Family Passes signed or hole punched.** Please contact the HOA office if passes are needed.  
*This rule will be strictly enforced by the pool staff.*
- Recreation Passes cannot be altered. Any violation of this rule will result in immediate revocation of the Recreation Pass and suspension of pool privileges.
- Children brought to the pool who are under the age of 12 must be accompanied by a responsible party age 16 or older. One person age 16 years or older must accompany every three children under the age of 5. One person 16 years or older must accompany every five children between the ages of 5 – 12. Please do not leave your children unattended at the pool unless they are over the age of 12 and can swim.

## **RECREATION PASSES**

Photo-ID Recreation Passes are required to enter the pool and courts.

- Residents not in good standing will not be issued passes. **If your account becomes delinquent, you may be subject to losing your pool and facility privileges.**
- A completed “Application for Recreation Pass” and VALID IDENTIFICATION must be submitted to **office** prior to a pass being issued.
- All Children over the age of 12 months will need passes.

Kiln Creek Owners Association members are expected to carry their Recreation Passes when using any recreation facility. Lost passes can be replaced at the KCOA office for a fee of \$10.00 per pass.

## **FAMILY POLICY**

**There will be no guests permitted except family.** Residents are required to ensure that your family is fully advised of KCOA rules/regulations. A resident (16 or older) **MUST** accompany the family at all times while in the pool area. The resident shall bear all responsibility for the family member and his/her conduct. Any misconduct on the part of the family member will result in the permanent or temporary revocation of family member privileges at the discretion of the Association. Management reserves the right to limit the number of family members per lot, based on occupancy on any given day.

Each family member is charged a **\$5.00** fee per day. Children under 2 are free. No more than 5 family members per lot will be permitted on any day. Family visits will be tracked to keep abuse of pool privileges to a minimum. **You may request a complimentary household family pass for 10 free admissions during the season.**

If your family will be with you all summer, you should consider obtaining a Seasonal Family Pass. Seasonal Family Passes are valid until the pool closes in September. The cost for a Seasonal Family Pass is \$50.00 each. No more than two Seasonal Family Passes will be issued per lot. **Seasonal Family must be accompanied by a resident. Seasonal Family may not use the pool by themselves.**

**ALL FAMILY ENTERING THE POOL AREA MUST BE FAMILY OF A RESIDENT. NO EXCEPTIONS WILL BE MADE.**

## **CARETAKERS**

THE POOL DOES NOT PROVIDE A CARETAKER SERVICE. All caretakers are required to obtain a Rec. Pass from the HOA office PRIOR to visiting the pool. Caretakers must accompany the resident needing to be supervised. Caretakers may not use the pool by themselves or bring other non-resident guests. All caretakers shall be in constant and vigilant attendance of his or her charges. Caretakers in violation will not be allowed to return as a caretaker.

## **WADING POOL RULES**

- The wading pool is NOT under the constant surveillance of the lifeguards. Children in the wading pool must be under the DIRECT supervision of a responsible person at least 16 years of age.
- Children over the age of 5 are *NOT* permitted in the wading pool
- Non-rigid, unbreakable toys are permitted in the wading pool.
- All non-toilet-trained children must wear swim diapers or tight rubber/plastic pants.
- One family permitted in wading pool per sign-up session.

## **LOCK & LOCKER USE:**

**There will be No locker use during the 2020 season.**
