2. UNDERSTAND that participation in the described activity involves potential danger and risk of injury. The inherent danger is understood and voluntarily assumed.
3. I recognize my responsibility to ensure that said minor child participates only in those activities for which he/she has the required skills, qualifications, training, and physical conditioning. I understand that the above named parish/school shall have no responsibility to pay for medical treatment and related costs if said minor child is injured.
