I hereby acknowledge and agree that participation in Shaare Torah programs comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with participating in Shaare Torah programs, including but in no way limited to illness or the exposure to infection from viruses or bacteria.

Coronavirus / COVID-19 Warning & Disclaimer

Coronavirus, COVID-19 is an **extremely contagious** virus that spreads easily through person-to-person contact. Federal and state authorities recommend social distancing as a means to prevent the spread of the virus. **COVID-19 can lead to severe illness, personal injury, permanent disability, and death. Participation in Shaare Torah programs or entering Shaare Torah facilities could increase the risk of contracting COVID-19.** Shaare Torah in no way warrants that COVID-19 infection will not occur through participation in Shaare Torah programs or entering Shaare Torah facilities. You understand that, while Shaare Torah may take a number of health precautions, it cannot eliminate the inherent risk posed by COVID-19 to the community, including programming participants and those with whom they contact. Waiver, Release, Indemnification & Covenant Not to Sue

In consideration of my participation in Shaare Torah programs and/or use of Shaare Torah facilities, I, the undersigned participant, agree to release and on behalf of myself, my heirs, representatives, executors, administrators, and assigns, **HEREBY DO RELEASE** Shaare Torah, its officers, directors, employees, volunteers, agents, representatives and insurers ("Releasees") from any causes of action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, my heirs, representatives, executors, administrators and assigns may have, now or in the future, against Shaare Torah on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to the use of

Shaare Torah facilities/equipment or participation in Shaare Torah programs, whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

In consideration of my participation in Shaare Torah programs and/or facilities, I, the undersigned participant, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to my participation in Shaare Torah programs.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in participation in Shaare Torah programs and that I am voluntarily assuming said risks. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death, I sustain while participating in Shaare Torah programs and that by, signing this agreement, I HEREBY RELEASE Releasees from all liability for such loss, damage, or death.

I hereby certify that this Agreement is to be construed as broadly as possible under Maryland law, which governs this Agreement without giving effect to any conflicts of laws principles. If any portion of this Agreement is deemed to be unlawful, invalid, or unenforceable, that portion shall not impact the validity and enforceability of all remaining portions of this Agreement. I further certify that I am of lawful age and otherwise legally competent to sign this agreement. I further understand that the terms of this agreement are legally binding and certify that I am signing this agreement, after having carefully read it, of my own free will and this agreement applies to me and all members of my household.
