NEST Community Learning Center (CLC) Volunteer Guidelines

Thank you for Volunteering for NEST Community Learning Center - we could not do this without you! The following are rules and guidelines to inform you and keep you safe. Please be on time and sign in on the volunteer clipboard. Due to the mobile nature of our program, each day can look a little different based on the students and volunteers who are there. You may work with different children each time, or even the day you are there. We appreciate your flexibility in "going with the flow"!

*NEST CLC Volunteers are expected to treat persons of all races, religions, and cultures or any disabilities with respect and consideration.

*NEST CLC Volunteers are to refrain from the use of language, physical conduct or behavior that could be misunderstood to be sexually suggestive, harassing, intimidating or offensive to program participants, fellow volunteers and staff. Permissible forms of non-verbal communications with children are as follows:

Hand to shoulder contact, Side by side hugs, Rustling of hair and pats on the head, "High Fives"

*If a child is injured during the program please bring the child to the attention of one of the NEST CLC Staff members. A NEST Staff Member will fill out an Incident Report for all injuries or other incidents.

*NEST CLC Volunteers are not permitted to offer or give ANY homemade food or treats (including gum).

*No NEST CLC Volunteer is permitted to stay and interact with children if they are using, in possession of, or under the influence of alcohol or illegal drugs.

*No NEST CLC Volunteer may leave the site with any child for any reason, nor be out of sight of a NEST CLC volunteer.

*By Ohio law, all NEST CLC Volunteers and Staff are MANDATED REPORTERS require to report any suspected abuse or neglect of a child to the proper authorities. Any Volunteer that does suspect the abuse or neglect of a child must report their suspicions the day of their suspicion.

*No photographs of the children in the program may be taken without permission of their parent(s)/guardian(s). The use of personal cell phone to photograph NEST Community Learning Center activities and its participants is prohibited.

*Volunteers and Staff of all NEST Community Learning Center Programs are expected to maintain confidentiality. It is not appropriate to talk about who is receiving benefits. NEVER share information with others regardless of an expression of good intentions.
