

Mini/Seasons & Celebrations/Limited Edition Sessions Policies and Release

In consideration of my session, upon the terms herewith stated, I hereby understand that Jennifer Simpson Photography will

- 1. Retain all copyrights of images taken during my photoshoot with her. This includes use of photos from my session on her blog, website and social media for promotion and advertising. I understand that such use may be opted out of in writing.
- 2. Request my permission in writing to use photos from my session for any publicly printed material for use other than promoting Jennifer Simpson Photography. (For example, if a clothing store you purchased an outfit from want to use an image for their purposes).
- 3. Provide me with password protected access to the final, edited digital files in an online gallery where I may select the number of images advertised in the current offer, download full resolution files selected, watermark free, and have the rights to reproduce those images for personal purposes including social media.

In addition, I the parent/guardian of the child signed up for this photo session:

- 1. Relinquish any right that I may have to examine or approve the completed product or products or the advertising copy or printed matter that may be used in conjunction therewith or the use to which it may be applied.
- 2. Understand that these images will be in a gallery from the entire day/set of days which will be viewable by those other participants given access with the password.
- 3. Understand that once the gallery is sent, I will have 2 weeks to view the images and select my downloads/make additional purchases. If I do not make my purchase/select my downloads within this window, I can request the gallery be reset but I will be required to pay the listed gallery prices for any prints/downloads and my right the those that came with the session are waived.
- 4. Release, discharge and agree to save harmless Jennifer Simpson Photography, his/her heirs, legal representatives or assigns, and all persons functioning under his/her permission or authority, or those for whom he/she is functioning, from any liability by virtue or any blurring, distortion, alteration, optical illusion, or use in composite form whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any processing thereof, as well as any publication thereto, including without limitation any claims for libel or invasion of privacy.
- 5. Release, discharge and agree to save harmless Jennifer Simpson Photography, his/her heirs, legal representatives or assigns, and all persons functioning under his/her permission or authority, or those for whom he/she is functioning, from any liability by incident or injury sustained my myself or my dependents while on Jennifer Simpson Photography's property.
- 6. Affirm that I am over the age of 18 or am the legal guardian for the minor aged subject(s) and that I have the right to contract photographs in my own name. I have read the above authorization, release and agreement, prior to its execution: I fully understand the contents thereof. This agreement shall be binding upon my heirs, legal representatives and assigns.
- 7. Will pay the full session amount on or before the session date.
- 8. Have reviewed, read, understand and agree to this electronic copy of Jennifer Simpson Photography's policies and release and will sign a copy in her presence.
