1) I have voluntarily chosen to receive the vaccination. 2) I am of legal age and authorized to execute this consent form. 3) I will immediately alert the vaccine administrator of any medical conditions which may adversely affect my personal health or effectiveness of the vaccine. 4) I have been counseled about potential side effects after vaccination, when they may occur, and when and where I should seek treatment. I am responsible for following up with my physician at my expense if I experience any side effects. 5) I should remain in the area for 15 minutes after the vaccination for observation or 30 mins if I have reported severe allergies or reactions to medications, food vaccines or latex. 6) I have read, or have had read to me, the fact sheet provided for the vaccine(s) to be administered. I have had the opportunity to ask questions, and all my questions have been answered to my satisfaction.
