

**PARK CITY WINE FESTIVAL VOLUNTEER
ACKNOWLEDGEMENT AND ASSUMPTION OF
RISK AND RELEASE**

The undersigned ("Participant") wishes to volunteer at the Park City Wine Festival produced by Team Player Productions, Inc. ("TPP") on September 29th - October 1st, 2022. As a condition to volunteering for this Event, Participant must execute this Acknowledgement and Assumption of Risk and Release. Some risks from volunteering at the Event may include, but are not limited to, lifting heavy items, moving/operating Event equipment, cleaning up broken glass, and additional reasonable tasks included in volunteering for a festival. Participant fully understands and acknowledges the inherent risks involved in the Event, and knowingly assumes and accepts those risks. Participant, for himself or herself, and his or her heirs and legal representatives, hereby releases, indemnifies and agrees to hold harmless TPP, Non-Profit Partners, Park City, Utah and all of their sponsors, officers, directors, shareholders, partners, representatives, employees, agents, volunteers, members, insurers, and all participants and sponsors of the Event, from any and all losses, costs, damages, claims, demands, rights and causes of action of whatever kind or nature, including attorneys' fees, and including any and all claims or causes of actions which may arise from illness, personal injuries, property damage, death or of any other damages or injuries not included herein, occurring during, or as a result of, my participation in the Event. This release includes any and all liability whether known or unknown, even though that liability may arise out of negligence or carelessness on the part of third parties, TPP, and/or any of the entities or persons mentioned above. In further consideration of my being granted the right to participate in the Event, Participant does hereby consent to and authorize TPP, its officers, directors, shareholders, partners, representatives, employees, agents, volunteers, participants, and sponsors, and/or any of the entities or persons mentioned above to obtain emergency medical treatment for me in the case of any illness or injury resulting from or occurring during my participation in the Event. Participant understands and accepts that any medical costs incurred with respect to emergency medical treatment will be Participant's sole responsibility. Participant agrees that Participant will, at all times during my participation in the Event (which includes the time before the Event during which Participant is preparing for the Event and a reasonable time after the Event during which time Participant is in the area in which the Event is held), adhere to all safety rules and other rules and regulations of the Event. Participant acknowledges that they are of legal age and fully competent, has read this Acknowledgement and Assumption of Risk and Release and fully understands it. If Participant is not of legal age, Participant and Participant's parent(s) or legal guardian acknowledge that they have each fully read the above Acknowledgement and Assumption of Risk and Release and understand it, and that Participant and Participant's parent(s) and/or legal guardian am/are fully bound by their execution of this Acknowledgement and Assumption of Risk and Release.
