

## **Keota Street Build Day Volunteer Packet**

Including FAQ's, parking information and a waiver for all volunteers to complete and sign.

Thank you so much for getting your group involved and volunteering to help build affordable housing in Northern Virginia! Habitat for Humanity of Northern Virginia (Habitat NOVA) works to brings people together to build homes, communities and hope.

What time do I arrive? 8:30 AM. If you arrive after 8:30, you may not be able to volunteer as all volunteers must attend orientation and a safety briefing.

What is the expected finish time for the work day? 3:00PM

Where is the build site? 3603 Keota Street, Alexandria VA 22303

Where can I park? Please Parallel Park on Linnean Street- the cross street into Keota Street. Keota Street is a narrow street, and we're trying to be good neighbors. See map included. Please be courteous of the other homes, do not block any driveways, and be aware of fire hydrants, yellow curbs, and where parking may be restricted.

What should I wear? Please wear comfortable, durable clothing: loose fitting jeans or work pants, short or long sleeve shirts, thick soled closed toed shoes or work boots. Most volunteers find it helpful to wear layers as the temperature can vary through the day. We do not allow leggings, tights, sleeveless shirts, or inappropriate footwear on our sites. This is FOR YOUR SAFETY. If you arrive in unsuitable clothing, you may be asked to leave.

What should I bring? Feel free to bring a bagged lunch and a water bottle to help keep you hydrated! We'll have all the tools and materials you'll need. You may bring your own equipment, but please make sure you leave with them. We are not responsible for any tools left behind.

What is the minimum age to volunteer? All volunteers must be 16 years or older to volunteer on a construction site. They must also have their parent or guardian sign their waiver form before volunteer.
