



Volunteer Release and Waiver of Liability Form

This Release and Waiver of Liability (the "release") executed on _____ (date) by _____ ("Volunteer") releases Transition Projects, Inc. and each of its officers, directors, agents, employees, administrators, successors or assigns ("Released Parties") from any and all liability, harm and damage, and waive any and all claims whatsoever for any injury, accident, damage or loss in connection with my traveling to and from, entry into, or service conducted in any Transition Projects Facility, including my actions or engagement in any activity under the supervision of Transition Projects staff and volunteers.

The Volunteer desires to provide volunteer services for Transition Projects and engage in activities related to serving as a volunteer. Volunteer understands that the scope of Volunteer's relationship with Transition Projects is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that Transition Projects will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to Transition Projects, with the understanding that reasonable precautions shall be taken to ensure the health and safety of myself and my property.

1. Waiver and Release

I, the Volunteer, release and forever discharge and hold harmless Transition Projects and its successors and assigns from any and all liability, claims, and demands, either in law or in equity, which arise or may hereafter arise from the services I provide to Transition Projects. I understand and acknowledge that this Release discharges Transition Projects from any liability or claim that I may have against Transition Projects with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to Transition Projects or occurring while I am providing volunteer services.

2. Insurance

Further I understand that Transition Projects does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of Transition Projects beyond what may be offered freely by Transition Projects in the event of injury or medical expenses incurred by me.

3. Medical Treatment

I hereby Release and forever discharge Transition Projects from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with Transition Projects.

4. Assumption of Risk

I understand that the services I provide to Transition Projects may include activities that may be hazardous to me including but not limited to working with and next to heavy equipment and machinery, handling sharp objects and tools, working next to individuals handling sharp objects and tools, and other activities involving risk of injury or harm. As a volunteer, I hereby expressly assume risk of injury or harm from all volunteer activities and Release Transition Projects from all liability.

5. Photographic Release

I grant and convey to Transition Projects all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by Transition Projects in connection with my providing volunteer services to Transition Projects.

6. Other

As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Oregon and that this Release shall be governed by and interpreted in accordance with the laws of the State of Oregon. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
