

**RiverSweep 2021 Anti-Litter Activity Program
Agreement to Participate, Release & Waiver**

PLEASE READ CAREFULLY.

I am an adult over eighteen years of age and I wish to participate in RiverSweep 2021 Anti-Litter Activity Program ("RiverSweep 2021"), and if applicable, wish my children or legal wards to participate and I give them permission to participate as indicated by my signature below.

As a condition to participation by me or my children, I recognize that RiverSweep 2021 is presented by NORTH CUYAHOGA VALLEY CORRIDOR, INC. d.b.a. CANALWAY PARTNERS and cooperating agencies and sponsors. I recognize that RiverSweep 2021 will involve activities that may present hazards and risks. As a condition to participation by me or my children in the activities of RiverSweep 2021, on behalf of myself and/or my children or wards, I waive and release any claims for loss or injury incurred or suffered which I or my children might make against Canalway Partners, cooperating agencies and sponsors and their respective employees, officers and agents for personal injury or property damage caused by negligence, acts or omission of Canalway Partners, cooperating agencies, sponsors, their employees, officers and agents, and other volunteers and participants.

I further agree to indemnify and hold harmless Canalway Partners, cooperating agencies and sponsors and their respective employees, officers, agents and volunteers from all liability, loss and expense including but not limited to damages, legal expenses and costs of defense in any matter arising from my participation in RiverSweep 2021.

I further agree to abide by all applicable rules and regulations promulgated for participation in RiverSweep 2021. I agree to follow the Center for Disease Control (CDC) guidelines with regard to precautions, face coverings and social distancing practices in order to reduce the spread of Novel Coronavirus, or COVID-19. This will require all participants and volunteers to maintain six (6) feet of separation distance, as much as possible; to utilize surgical masks or face coverings such as scarves, bandanas and handkerchiefs to reduce the risk of exposure to myself and others. It is also required of everyone to wash or sanitize their hands after using the restroom, sneezing or coughing.

If you have tested positive for COVID-19 within fourteen (14) days, or if you have symptoms of COVID-19 (dry coughing, sneezing, elevated temperature, headache, loss of smell or taste, shortness of breath, etc.) or if you have had close contact with a person who is COVID-positive within fourteen days, you must self-isolate.

I agree to follow the instructions of all supervisors and/or instructors who are affiliated with RiverSweep 2021.
